How are solar PV projects promoted in Bulgaria?

Large-scale, commercial and industrial PV projects in Bulgaria are promoted through premium agreements. All solar PV plants with capacity of 4 MW and higher can apply for them. Premium agreements are concluded with the Energy Security System Fund (ESSF). RES producers also sign contracts with the National Electricity Company (NEK).

How to start a business in Bulgaria?

The LLC is suitable for small and medium-sized businesses and, according to law, it must have an appointed manager. The joint stock company is more suited to those who want to start a business in Bulgaria as a large one, as it has no restrictions on the transfer of shares.

What is solar power & how does it work in Bulgaria?

Solar power allows for a wide range of applications - from residential, through commercial to utility scale. Government policy and legislation aim to support investors in all types of photovoltaic projects. The support schemes in Bulgaria include premium contracts and a feed-in tariff scheme.

Can foreign investors open a business in Bulgaria?

Under the Bulgarian Commercial Code, foreign investors can open a business in Bulgaria just like any other local investor. There are no special requirements when opening a company in Bulgaria, except when registering a joint stock company.

What types of companies can you start in Bulgaria?

Popular industry sectors include the chemical industry, electronics, engineering, and human health care. You can create a joint stock company, limited liability company, or representative officewith relative ease. Bulgarian law mirrors that of EU legislation, and company registration takes days rather than weeks.
