### Who are BW ESS & Penso power?

BW ESS and Penso Power are currently constructing the 100MW / 331MWh Bramley battery energy storage system project in Hampshire with energisation expected in Q4 2024 and recently signed a seven-year tolling agreement with Shell Energy Europe Limited.

#### Who is BW ESS?

About BW ESS BW ESS is a global energy storage owner-operator, moving with speed to develop, build and operate market-leading energy storage projects across multiple countries.

#### What is BW ESS tolling agreement?

The seven-year tolling agreement is for the 100MW/330MWh Bramley BESS currently under construction in Hampshire. Image: BW ESS. BW ESS and its partner Penso Power have signed the first long-term tolling agreement for a single battery energy storage system (BESS) asset in Great Britain with Shell Energy Europe.

#### What is shell doing with BW ESS & Penso power?

Under the agreement, Shell will trade the BESS into a range of ancillary services and wholesale markets, paying BW ESS and Penso Power a fixed fee. The 100MW/330 megawatt-hour (MWh) Bramley BESS site, currently under construction in Hampshire, UK, is also the first project in Europe to deploy Sungrow's PowerTitan 2.0 liquid-cooled BESS system.

#### Why did BW ESS merge with BW Group?

BW ESS is part of BW Group, a global maritime company founded in 1955 that cites shipping, floating infrastructure, deepwater oil and gas production and new sustainable technologies among its operations. The merger seeks to enhance the company's energy storage capabilities and solidify its presence within the renewable energy market.
