

## China-europe solar energy storage grounding

Are Chinese-manufactured solar panels putting up in European warehouses?

Chinese-manufactured solar photovoltaic (PV) panels are piling up in European warehouses, with Rystad Energy forecasting 100 GWdc of solar capacity in storage by the end of 2023.

What will China's energy storage systems look like in 2024?

Furthermore, the sustained growth in the demand for utility-scale Energy Storage Systems (ESS), driven by challenges in the consumption of wind and solar energy, is noteworthy. TrendForce predicts that China's new utility-scale installations could reach 24.8 gigawatts and 55 gigawatt-hoursin 2024.

What types of energy storage installations are there in China?

Clearly, the predominant types of energy storage installations in China at present are still mandated installations for renewable energy and standalone energy storage. The primary driver behind the surge in domestic energy storage installations is the mandatory installation requirements.

Where are Chinese solar panels coming from?

The imports are heading to several key destinations, including the Netherlands, Spain, Germany, Poland, France, Greece, Italy, and the UK. The Netherlands was the standout leader in Chinese PV imports in 2022, bringing in almost 45 GWdc alone, more than ten times the amount of panels installed domestically across the year.

Will European solar panels keep up with the growth of imported solar panels?

These goals include a target for 30 GWdc of European manufacturing along the entire value chain by 2025 and 40% of installed solar PV being manufactured within the continent by 2030. Despite these ambitious goals, between 2019 and 2022, locally-made modules could notkeep pace with the growth of imported panels.

Will the European Parliament block solar panel imports from China?

Two policies are working their way through the European parliament that could lead to obstacles for solar panel imports from China: the corporate sustainability due diligence directive and the forced labour regulation. Both will require agreement between the parliament and the EU's 27 member states.
