



Diversified energy storage investment

Will battery energy storage investment hit a record high in 2023?

After solid growth in 2022, battery energy storage investment is expected to hit another record high and exceed USD35 billion in 2023, based on the existing pipeline of projects and new capacity targets set by governments.

Is battery energy storage a good investment?

There are signs of life among important new and emerging technologies, where absolute investment remains relatively small but growth rates are high. Investment in battery energy storage is hitting new highs and is expected to more than double to reach almost USD 20 billion in 2022.

Are energy storage technologies more cost effective and ready for commercialization?

Through investments and ongoing initiatives like DOE's Energy Storage Grand Challenge --which draws on the extensive research capabilities of the DOE National Laboratories, universities, and industry--energy-storage technologies are now more cost effective and ready for commercialization.

Which countries invest in battery energy storage in 2022?

Grid-scale battery storage investment has picked up in advanced economies and China, while pumped-storage hydropower investment is taking place mostly in China. Global investment in battery energy storage exceeded USD20 billion in 2022, predominantly in grid-scale deployment, which represented more than 65% of total spending in 2022.

Why should oil & gas companies invest in diversification?

This is a once-in-a-generation opportunity for producer economies to fund diversification activities and for the major oil and gas companies to deliver more diversified spending.

What are some interesting energy storage ETFs?

Another interesting energy storage ETF is GRID, which is focused on alternative energy infrastructure companies such as power management company Eaton Corp. (ETN), industrial conglomerate Johnson Controls International PLC (JCI), and electronics and automation pioneer Abb Ltd. (ABB).
