The largest solar generation plus energy storage project ever to be built in the Caribbean has been announced by the Government of St. Kitts and Nevis, the state-owned St. Kitts Electric Company (SKELEC) and Leclanché SA (SIX: LECN), one of the world's leading energy storage companies.

With the project's completion, Leclanché will have enabled St. Kitts and Nevis to be in the global top tier of countries utilising renewable energy with over 30% penetration. Leclanché's battery storage system will ensure that the continuous fluctuating power demand on the island matches the instantaneous grid capacity (load balancing and ...
