Why did GCL change its name to GCL Technology Holdings Limited?

On February 21, GCL-Poly Energy Holdings Limited announced a proposal from its Board of Directors, according to which the company is to change its name from "GCL-Poly Energy Holdings Limited" to "GCL Technology Holdings Limited", in accordance with its future strategic focus on silicon materials technology and technology innovation.

Is GCL-Poly A Good Company?

On March 28, GCL-Poly and GCL New Energy each officially gave their FY 2021 reports. GCL-Poly has achieved its best business outcomes so far, with an operating income of 19.698 billion yuan.

Is GCL Poly A Chinese company?

As of 2009 it was the largest supplier of polysilicon in China, and is also a supplier of electronic wafers for the solar industry. GCL-Poly listed at the Hong Kong Stock Exchange in 2007.

What is GCL-Poly energy?

GCL cold hydrogenation and rod-shaped silicon processing and its FBR granular silicon manufacturing are self-innovated and self-developed achievements. Solar silicon materials aside, GCL-Poly Energy has also made major breakthroughs in electronic-grade polysilicon, large-scale perovskite and other fields, filling domestic gaps in China.

Who owns GCL-Poly?

In November 2009, China Investment Corporation (CIC) bought a HK\$5.5 billion (\$710 million) minority stake in GCL-Poly. February 14, 2014 GCL-Poly implement Subscription Rosenthal Group 360,000,000 new shares at a price of four yuan per share, a discount of 70.37% compared with before the suspension.

Who is GCL Technology Holdings Limited (GCL)?
