A leading businessman has criticised Environment and Infrastructure's (E&I) new electricity strategy for Guernsey. Jon Moulton said the strategy should come after a long-term deal on power supply has been signed with French energy suppliers. The current deal for electricity supply with French energy supplier EDF is set to run out in 2027.

How does Guernsey get its electricity from France?

Mr Moulton, from the centre-right think tank the Guernsey Policy and Economics Group (GPEG), said: "You cannot decide on a strategy until you've worked out what our French supplier wants to do." Currently around 93% of Guernsey's electricity is sent through a cable via Jersey, from France.

How is Guernsey connected to the European electricity grid?

Guernsey is connected to the European Electricity Grid through a submarine cable link (via Jersey) into the Cotentin peninsula, due east of Jersey.

Is E&I planning a small windfarm off Guernsey?

Paul Fletcher, from renewable energy company Renew Guernsey, is also concerned about the direction chosen by E&I. He said the E&I proposals for a small windfarm off Guernsey would be very expensive, and in his opinion "not a good idea".
