Despite being geographically well suited for developing solar energy, Kosovo is facing legal, administrative, and financial barriers such as prolonged authorization procedures, solar PV installed capacity limitation, lack of RES skills and capacities, protracted legalization process, lack of public awareness, and modest support schemes, that

Kosovo has announced the winner of its first solar power tender, with a consortium led by Swiss construction group Orllati securing a 100-MW project with a bid of EUR 48.88 per MWh. Kosovo solar backup power

The European Investment Bank (EIB) said on Monday that it has signed a EUR-33-million (USD 35.9m) investment loan for the construction of a solar farm with a targeted capacity of 100 MW/120 MWp in Kosovo.

Dukagjini Solar intends to install two photovoltaic units of 96 MW of alternating current power each. The planned combined peak capacity is 250 MW. The Transmission, System and Market Operator (KOSTT) of Kosovo* said its Chief Executive Officer Mustafë Hasani signed an agreement for a solar park in Peja-Pe that is expected to start ...

A consortium led by Switzerland-based construction company Orllati was selected to build and operate a solar park of up to 105 MW in connection capacity for 30 years including a 15-year contract for difference. The group won the first renewable electricity auction in Kosovo* with a bid of EUR 48.88 per MWh.
