The offer process includes providing information about the land, conservation goals, and the desired conservation practices. Detailed enrollment instructions and deadlines are available through the local FSA office.

### Where can I file a conservation application?

Applications may be obtained and filed at any time with your local USDA Service Centeror conservation district office.

#### How do I get NRCS & USDA?

Agency staff have expertise in easement administration and in agricultural and natural resources conservation planning and management. If NRCS or USDA are new to you, the first step would be to visit your local USDA Service Center, meet your local conservationists, and establish records used to qualify landowners for USDA programs.

Express Reserved Rights: When the federal government reserves land, it may explicitly define and reserve water rights for a particular purpose. Implied Reserved Rights: When the federal government reserves land for a particular purpose and is silent about the reserved water rights, a water right may be implied in order to carry out the purpose of the reservation.
