What laws regulate safety and health at work in Lithuania?

The main legal acts regulating policy in the area of safety and health at work and its implementation in Lithuania are the Labour Code and the Law on Safety and Health at Work (No IX-1672).

What is the Commission on safety & health of the Republic of Lithuania?

In order to coordinate the interests of the State, workers and employers in the field of safety and health at work, the Commission on Safety and Health of the Republic of Lithuania was established by means of a tripartite principle of cooperation between the social partners (parties)

Who implements the state policy in Occupational Safety & Health in Lithuania?

In Lithuania, the Ministry of Social Security and Labour) implements the state policy in the field of occupational safety and health (OSH) according to its competence (together with the Ministry of Health).

What is Occupational Safety and health (OSH) in Lithuania?

In Lithuanian legislation occupational safety and health (OSH) is defined as all preventive measures intended for the preservation of functional capacity, life and health of workers at work.

How to implement Osh in Lithuania?

Training and instructing workers and giving them mandatory instructions in order to satisfy the requirements on OSH. The main legal acts regulating policy in the OSH area and OSH implementation in Lithuania are the Labour Code and the Law on Safety and Health at Work .

What is Lithuanian hygiene standard HN 32?

The main indicators of safety and health at work status are the number of accidents at work and the incidence of occupational diseases. Information on the state of health and safety of workers in the country can be found on the website of the State Labour Inspectorate of the Republic of Lithuania under the Ministry of Social Security and Labour.
