On November 14, 2023, York Energy Storage, LLC, filed an application for a preliminary permit, pursuant to section 4(f) of the Federal Power Act (FPA), proposing to study the feasibility of the York Energy Storage Waterpower Project to be located near Lake Clarke, formed by the Safe Harbor Dam on the Susquehanna River, and Chanceford Township ...

The York Energy Storage proposal would take advantage of the drop to the river to store energy from the regional electrical grid, pumping water uphill to the reservoir when demand is low compared to generation capacity.
