The formulation of a cohesive, long-term policy is essential to ensure a steady gas supply, aligning with both European energy security needs and Algerian interests.

Beyond merely being a credible supplier, Algeria's strategic focus leans more towards market security than catering solely to the needs of its customers (Witton, 2010). This distinction highlights the nuanced interpretation of energy security from the perspectives of both the supplier and the consumer.
