

# Northern Mariana Islands dg cabinets

What type of government does the Northern Mariana Islands have?

The Northern Mariana Islands is an unincorporated territory of the United States, and in a political union with it in the form of a commonwealth. Executive power is exercised by the governor. Legislative power is vested in the two chambers of the legislature. The judiciary is independent of the executive and the legislature.

Is Guam part of the CNMI?

The CNMI includes the 14 northernmost islands in the Mariana Archipelago; the southernmost island, Guam, is a U.S. territory. The Northern Mariana Islands were listed by the United Nations as a non-self-governing territory until 1990.

Who controls the executive branch in the Northern Mariana Islands?

Replicating the separation of powers elsewhere in the United States, the executive branch is headed by the governor of the Northern Mariana Islands; legislative power is vested in the bicameral Northern Mariana Islands Commonwealth Legislature and the judicial power is vested in the CNMI Supreme Court and the trial courts inferior to it.

What democratic system does the Northern Mariana Islands have?

The Northern Mariana Islands have a multiparty presidential representative democratic system. They are a commonwealth of the United States. Federal funds to the commonwealth are administered by the Office of Insular Affairs of the U.S. Department of the Interior.

Who owns the Northern Mariana Islands?

Historically the Northern Mariana Islands have been subject to the Trust Territory of the Pacific Islands Agreement. Each power contributed elements that mixed with local indigenous cultures to form the current of the Northern Mariana Islands. United States citizenship was granted in 1986.

How many members are in the Northern Mariana Islands Legislature?

The Northern Mariana Islands Commonwealth Legislature has two chambers. The House of Representatives has 20 members, elected for a two-year term from seven districts. The Senate has 9 members, elected for a four-year term in two staggered classes.
