What is the Danish Center for energy storage?

Danish Center for Energy Storage, DaCES, is a partnership that covers the entire value chain from research and innovation to industry and export in the field of energy storage and conversion. The ambition of DaCES is to strengthen cooperation, sharing of knowledge and establishment of new partnerships between companies and universities.

Without the hydrogen scenario,the potential for hydrogen-based energy storage in Denmark will be limited.
