Is South Georgia a small island?

It is a remote and inhospitable collection of islands,consisting of South Georgia and a chain of smaller islands known as the South Sandwich Islands. South Georgia is 165 kilometres (103 mi) long and 35 kilometres (22 mi) wide and is by far the largest island in the territory.

Where are South Georgia and the South Sandwich Islands located?

South Georgia and the South Sandwich Islands (SGSSI) are a chain of Subantarctic islands in the Southern Ocean surrounding Antarctica. The islands are an overseas territory of the United Kingdom: they have no permanent residents and their administration is physically based in the Falklands,but since 1985 they have been a separate jurisdiction.

Who owns South Georgia and the South Sandwich Islands?

The United Kingdomclaimed sovereignty over South Georgia in 1775 and the South Sandwich Islands in 1908. The territory of "South Georgia and the South Sandwich Islands" was formed in 1985; previously,it had been governed as part of the Falkland Islands Dependencies.

What happened to South Georgia and the South Sandwich Islands?

In 1985,South Georgia and the South Sandwich Islands ceased to be administered as a Falkland Islands Dependency and became a separate territory. The King Edward Point base,which had become a small military garrison after the Falklands War,returned to civilian use in 2001 and is now operated by the British Antarctic Survey.

Why is the South Georgia & South Sandwich Islands marine protected area undergoing a review?

The South Georgia and South Sandwich Islands Marine Protected Area is undergoing its second five-yearly review. Recovery of baleen whales coupled with climate change,means managers must be alert to alternative future ecosystem states. Areas of little economic interest within the MPA remain data poor with little monitoring.

Why is South Georgia a marine protected area?

On 23 February 2012,to protect marine biodiversity,the territory's government created the South Georgia and the South Sandwich Islands Marine Protected Area - comprising 1.07 million km² (410,000 sq mi). After the Falklands War in 1982,a full-time British military presence was maintained at King Edward Point on South Georgia.

Earlier this year, our dream was realized: South Georgia and the South Sandwich Islands" received the highest MPA designation status possible. We were elated to learn that 449,000 square kilometers of the region have been entirely closed off from fishing activity.
