The electricity rates in the Federation of St. Christopher (St. Kitts) and Nevis are \$0.26 per kilowatt-hour (kWh). This is lower than the Caribbean regional average of \$0.33/kWh.

In 2010, a 2.2 MW wind power plant, consisting of eight GEV MP 275/32 turbines rated at 275 kW each, was completed on Nevis. The island has now embarked on a very ambitious goal to achieve 60% renewable energy consumption by the year 2015.
