Why should Timor-Leste invest in Greater Sunrise?

The development of Greater Sunrise has the potential to deliver value to both the people of Timor-Leste and shareholders. The Sunrise development comprises the Sunrise and Troubadour gas and condensate fields, collectively known as Greater Sunrise.

According to the plan, the multi-year Tasi Mane development of three industrial clusters on the south coast will form the backbone of the Timor-Leste petroleum industry. This will include the Suai Supply Base cluster, the Betano refinery and petrochemical industry cluster, and the Beaco LNG plant cluster.
