The Midland XALT factory has produced battery cells and packs, such as thermal management, safety, software and electronics, for over a decade. "The know-how and skills built up in the team over this time are a key asset, especially in such a rapidly growing start-up industry," Freudenberg said.

Will Freudenberg E-Power Invest in Midland xalt?

Midland's XALT factory can expect to see large investments from Freudenberg e-Power company in the years ahead. On Feb. 2 the company announced it would invest a "double-digit million sum in the expansion" of its battery business and capacities. This investment would go partially into the Midland XALT factory, and there's more to come.

Who owns XALT Energy?

Freudenbergis acquiring 49.9 percent of the outstanding membership units of the joint venture from partner MBP Investors, a Townsend Ventures affiliate, and will thus become the sole owner of XALT Energy, LLC.
